DIRECTIONS TO HASSANI, FOCAS & FIFER, P.A.

From the Interstate 695– the Baltimore Beltway, coming from the EAST:

Take Exit 27 South, Dulaney Valley Road;
Continue southbound on Dulaney Valley Road for about 1 mile until you reach the roundabout.
Go around the roundabout and take the 3rd right, which is York Road south.
Make a right at first traffic light after the circle. This is West Pennsylvania Avenue.

Our offices are in the HOWARD BANK building (formerly SunTrust Bank) about 1/2 block down on the right side at 22 W. Pennsylvania Avenue.

From the Interstate 695– the Baltimore Beltway, coming from the WEST:

Take Exit 26 South, stay in the center lane as you approach the traffic light at West Road.
Make a LEFT on to West Road and then stay on the right.
Make a RIGHT at the next light onto York Road south.

Continue southbound on York Road for about 1 mile (past 3 traffic lights) until you reach the roundabout just over the top of the hill.

Go around the roundabout and take the 2nd right, which is York Road south.

Then, make a right at first traffic light after the circle. This is West Pennsylvania Avenue.

Our offices are in the HOWARD BANK building (formerly SunTrust Bank) about 1/2 block down on the right side at 22 W. Pennsylvania Avenue.

PARKING FOR CLIENTS

Metered parking is available along Pennsylvania Avenue. There are also metered parking lots behind our building, and a parking garage directly across the street on Pennsylvania Ave.

You can access the metered lots directly from Allegheny or from Washington Avenue through the alley. If you are at the light at Pennsylvania Avenue and Washington Avenue, make a right then make the first right into the alley that is directly behind Bank of America (it is called “Watkins Way”). Look for the canopy on our building “22 W Pennsylvania Avenue”, it will be on your right. The metered lots will be on your left. If parking behind the building, you may come in the back door. Go up 1 flight of stairs and go through the door on your right. Then take the elevator up to the 6th floor. We are located in Suite 606.
